

Corporate & Private Workshops

This hybrid platform requires less travel and time away from home and work and allows the clinician the flexibility to complete the online portion of the course at a self-pace without the demand of attending a pre-determined, scheduled workshop.

After completion of the online component, participants will attend the live, one-day hands-on clinical competency course. To ensure a complete, comprehensive learning experience, we encourage participants to attend the one-day, live, hands-on course AFTER completion of the online content.

Certification is earned once participants have completed BOTH the online and live portions and have passed BOTH the written exam for the online component, and the competency based exam during the one-day live component.



Certification Courses Available

Vestibular Rehabilitation Certification


This combined 19.5-hour (12 hours online, 7.5 hours live), competency-based course will be the foundation for the learner as a Certified Vestibular Specialist. The course will expand upon introductory coursework for vestibular dysfunction as it relates to benign paroxysmal positional vertigo (BPPV), and vestibular hypo-function, including assessment and rehabilitation. Canalith repositioning maneuvers (CRM) and vestibular rehabilitation therapy (VRT) protocols are included as part of the comprehensive management plan for identifiable vestibular and balance system disorders. Evidence-based integration into management principles will be disseminated throughout both the online and live components of the course.

Vestibular Rehabilitation & Concussion Certification

This combined 30-hour course (21 hours online, 9 hours live) is geared toward the clinician interested in learning evidence-based management for both Vestibular and Concussion (m-TBI) patients. This workshop is comprised of the Vestibular Rehabilitation Certification Workshop and a comprehensive Concussion Management module, consisting of evaluation and management tools for sports and non-sports related m-TBI. Evidence-based protocols will be presented, demonstrated, and practiced throughout both the online and live components of the course to ensure clinicians produce excellent outcomes.
